AGENCY

Golf Travel Pty Ltd trading as On the Tee and On the Tee Travel (OTT), acts only as a booking agent making reservations with the companies or associates offering services contained in the tour. Whilst acting in good faith, OTT does not accept any responsibility for default causing loss or injury to person or property whether by negligence or otherwise on the part of OTT employees, tour operators, destination management providers, hotel managers/owners, golf clubs, restaurants, transport companies, airlines or their employees. All bookings are made on your behalf subject to the terms and conditions, including conditions of carriage and limitations of liability, imposed by these service providers. Your legal rights in connection with the provision of travel services are against the specific provider and, except to the extent a problem is caused by fault on our part, are not against us. Specifically, if for any reason (excluding fault on our part) any travel service provider is unable to provide the services for which you have contracted, your rights are against that provider and not against us.

TRAVEL INSURANCE

It is a condition of booking with OTT that all travellers have the correct comprehensive travel and medical insurance to cover themselves for the duration of their tour. This is the sole responsibility of the traveller. This insurance should include cover in respect of, but not limited to, the following: Health Insurance, including full medical, emergency evacuation and repatriation cover for the full period of travel is compulsory. Travellers will be charged directly by the relevant service providers for any emergency services they may require. Cancellation & Curtailment: If, for any reason, a traveller has to cancel prior to departure, the traveller may forfeit a large portion, or even the entire cost of the booking. Furthermore, should a traveller have to depart prior to completion of the trip, the cost of the portion of the tour that has not been completed is not refundable. It is the responsibility of the traveller to take out appropriate insurance to cater for this eventuality. Damage/theft/loss of personal luggage, money and/or goods. OTT and any person or agent acting for or on behalf of OTT, will not take responsibility of any costs or losses incurred or suffered by travellers with regard to, but not limited to, any of the above-mentioned eventualities.

FLIGHTS

International flights are not included.
The trip starts on 6 April 2020 at Atlanta International Airport with a transfer to Augusta accommodation and ends on 13 April with a transfer back to Atlanta International Airport.

EXCLUSIONS

Excluded are international airfares, visa costs, excess baggage charges, drinks unless specified, other meals not specified in itinerary, gratuities, items of a personal nature, golf equipment rentals and amenities for golfers.

DEPOSITS AND PAYMENTS

On receipt of the completed booking form, an invoice for the deposit will be issued. Receipt of the deposit secures your place on the tour. Payment is due within 7 days and may be made by credit card or by direct deposit into our bank account. Please note that credit card payments incur a 2% surcharge. Please ensure that you have adequate travel insurance to cover any unforeseen cancellation as the deposit is non-refundable. The final payment will be invoiced on 2nd December 2019, and is due on 15th December 2019. Please contact us should you wish to pay the final balance earlier.

CANCELLATIONS

Cancellation requests must be provided in writing. The following cancellation charges apply:

- Deposit is forfeited if cancelled prior to when final payment is required.
- For cancellations after the final payment has been made 100% of the package value may be forfeited.
- Additional cancellation fees are subject to terms and conditions of suppliers, including but not limited to accommodation, restaurants, airlines, transport suppliers and golf courses. OTT will endeavor to recover costs on behalf of clients.

TOUR AMENDMENTS

Items on the itinerary may change due to circumstances beyond the control of OTT or appointed agents or suppliers. Changes may affect costings, itineraries, hotels, golf courses, flights and transfers. OTT will do all possible to maintain the tour schedule and standard or obtain suitable and comparable alternatives. The

order of days is also subject to change and times may change. On the Tee Travel will advise of any changes as soon as they are known.

PASSPORTS, VISA AND TRAVEL ADVICE

Please check www.smarttraveller.gov.au for important travel advice to the USA. Travelers must ensure that they comply with all visa and passport requirements. Please check for details. Most Australian citizens will require an ESTA visa waiver - please see <https://esta.cbp.dhs.gov> if they are travelling as a tourist. Your passport must be valid for at least six months from the date of return. Visa costs are at your own expense.

ACCEPTANCE OF RISK

There is a higher degree of personal risk due to participation on the tour. Some of the risks include:

- Locations that are remote in time, distance and/or accessibility from any medical treatment facility.
- Other risks incidental to the tour or activities ancillary to the tour.

You agree that you have been advised of the risks associated with the tour and voluntarily chose to participate in the tour fully accepting that the materialisation of such risks may cause personal injury, death, property damage or economic loss.

SUPPLIER BONDS OR DEPOSITS

Accommodation suppliers may require a bond or credit card imprint to cover items such as mini bars etc. The client agrees to provide such bonds or deposits as reasonably requested.

ADDITIONAL CHARGES

Additional charges may occur which are outside of OTT's control or may be the fault of a member(s) of the tour group. The company will not be responsible for any such additional charges and retains the right to demand any such charges from the client without reservation if any claim should be made on it by any supplier.

COURSE RENOVATIONS OR ALTERATIONS AND INCLEMENT WEATHER

Golf course renovations occur at various times of year as part of the normal maintenance. Where possible the group will be advised at the time of final confirmation, however the suppliers reserve the right to amend the date or may provide OTT with minimum notice. Weather interruptions to our itinerary are beyond our control. Every endeavour will be made to minimise the disruption to golf play. No refunds apply where this occurs.
